Hosting of at least one job fair

Co-sponsoring of at least one job fair with organizations in the business and professional community who employ women and minorities

Participation in at least four events, including conventions, career days, workshops, and similar activities that interest the community interested in broadcast employment issues

Establishment of an internship program designed to assist members of the community to acquire skills necessary for broadcast employment

Participation in job banks, Internet programs, and other programs designed to promote outreach generally (including notification of specific job vacancies)

Participation in scholarship programs designed to assist students interested in pursuing a career in broadcast journalism

Establishment of training programs designed to enable station personnel to acquire skills that could qualify them for other careers

Establishment of a mentoring program for station personnel

Participation in at least four events or programs sponsored by educational institutions relating to career opportunities in broadcast journalism

Sponsorship of at least two events in the community designed to inform and educate members of the public about broadcast journalism

Listing of each upper-level category opening in a job bank or newsletter of media trade groups whose members include women and minorities

Provision of assistance to unaffiliated non-profit entities in the maintenance of web sites that provide career information and/or other career development assistance pertinent to broadcasting

Provision of training to management level personnel as to methods of ensuring equal employment opportunities

Provision of training to personnel of unaffiliated non-profit organizations interested in broadcast employment or to job candidates for broadcast positions

Participation in other activities designed by the station reasonably calculated to further the goal of disseminating information about broadcast employment to job candidates who might otherwise be unaware of such opportunities
